3. Dividend & Record date: The Board of Directors at its Meeting held on April 29, 2025, has recommended a final dividend of ₹ 1/- (Rupee One) per equity share (i.e. 10%) of face value of ₹ 10/- each for the financial year 2024-25.

- Record Date:** The Company has fixed **Tuesday, June 03, 2025** as the Record Date for the purpose of determining the eligibility of members to attend and vote at the 25th Annual General Meeting (AGM) and to receive dividend for the financial year 2024–25, if approved at the AGM.
