**E-Voting Information:** Pursuant to Section 108 of the Companies Act, 2013, Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended), Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015, and SS -2 on General Meetings issued by ICSI, the Company is providing its members the facility to exercise their right to vote on the resolutions proposed to be passed at the 26<sup>th</sup> AGM by electronic means through the **e-voting platform** provided by **National Securities Depository Limited (NSDL)**.
