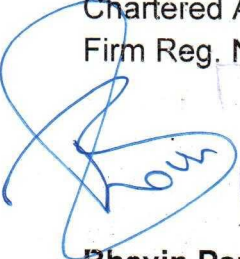

1. 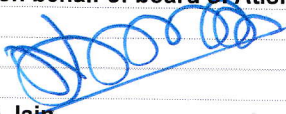


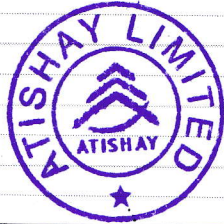
